DECLARE

- that I have received, read carefully and understood every part of the event regulations, and fully accept the same with reference to the proper running of the event and its security;
- that I have received, read carefully and understood every part of and accept fully the general information about the risks of the practice of mountain biking on trails and off-road tracks;
- that I have received, read carefully and understood every part of and accept fully the documentation specific to the evaluation and risk assessments of the event;
- that I have received, read carefully and understood every part of and accept fully the documentation related to the general security measures for the event and the emergency procedures for the event;

- that I have walked the event course and have seen the signs put in place by the organisation in order to indicate and highlight the narrowest sections of the course, the most hazardous obstacles and unexpected turns

In the light of which I ACKNOWLEDGE and DECLARE that, subject to the rules in force and to the particular nature of the event and of the sporting discipline of mountain biking, the organisers have done everything possible to make the event safe and to avoid the occurrence of accidents and damage to people or objects and that they have also provided a proper security protocol for use if necessary.

DECLARE

- that I have received, read carefully and understood every part of and accept fully the documentation related to the classification of the difficulty of the course;
- I have experience of off-road bike riding, and understand therefore the facts considered in the assessment of the difficulties I may encounter in riding the race route;
- I have the cycling skills and technical and physical capacity to follow the route both in daytime and at night;

- I am in good health and am not aware of any pre-existing medical condition or injury that could put me at risk during the event, and I am not taking substances and / or drugs that are contra-indicated in the sport of cycling

I therefore DECLARE that I am able and capable both psychologically and physically to follow the route the organisers have planned for this event

I further DECLARE:

- I have read and understood the route of the ride and have carefully checked all potentially dangerous and / or tricky points, taking account of poor visibility or conditions caused by fatigue. I have also considered the risks to my health and / or my physical integrity and to that of third parties arising from my participation in the event;
- I am aware of the foreseeable and typical risks inherent in riding a Mountain Bike;
- I understand and agree that, despite the clear commitment of the organisers to ensure that the participants enjoy the maximum reasonably possible security, there are still residual risks (also called "sports risks") that can not be eliminated totally because they are inherent to the discipline of mountain biking;
- I accept that many people will attend the race, whose skill level and cycling technique is unknown to me, and therefore crowded situations may arise on the route that could increase the risk of accidents and clashes;
- I chose to attend the event under my own initiative and at my personal responsibility, and am aware that as in any sporting event there may be risks of injury or accident.

I therefore DECLARE that I assume full responsibility for taking part in this so-called "risky sport", and am taking this decision with full understanding and knowledge. I accept sole responsibility for the conduct of my Mountain Bike during the event in the region of "le Manie", considering of course that this responsibility also applies to third parties

I UNDERTAKE

not to provoke or put myself in a situation that causes damage to property or persons in any way even if this were to affect all or part of my sports performance

I INDEMNIFY

the organisers, the volunteers, the police, the authorities, owners and / or users of land, collaborators, employees, sponsors and all involved in the event, against any liability, civil, criminal or administrative for any harmful incident that should happen due to my

conduct in the course of the event, the rides before, during and after the event, and even outside the marked route for the event

- I have a third party insurance policy against accidents (RCT)
- I do not intend to have an insurance policy against accidents or an RCT (Third Party Liability policy) (even though I know I can get one at the event)
